Your definition of high-need students: Students living in poverty, students of color, students with special needs, English language learners, and students exposed to chronic stress or trauma.

Brief description of proposed project, including project activities: We will: (a) partner with afterschool staff in a small number of Nebraska 21st Century Community Learning Centers (CCLCs) to design low-cost, flexible, evidence-based strategies for social emotional learning (called "SEL Kernels") and related implementation supports for afterschool settings; (b) implement and evaluate SEL Kernels in 90 CCLC sites across Nebraska; and (c) make available the final set of SEL Kernels materials and project results for broad distribution.

Summary of project objectives and expected outcomes: Improve the social, emotional, behavioral, wellbeing, and learning supports available to high-needs students in afterschool programs, and observe gains in child, adult, and setting-level outcomes at multiple points across the two-year implementation and evaluation period.

Describe how the proposed project is innovative: SEL Kernels represent a new approach to SEL designed for a variety of learning settings including OST that is flexible, low-cost, strategy-based, and targeted to discrete SEL skills. This kind of approach is badly needed as children face ongoing mental and emotional challenges tied to the pandemic and as schools face opposition to social-emotional learning curricula.

Identify other studies and/practice related to the proposed project: There are many studies (including correlational, randomized control trials, and meta-analyses) of social-emotional learning interventions, primarily focused on school-based curricula. In addition, a great number of school districts around the country currently implement social and emotional learning curricula, although implementation challenges are a substantial barrier to impact.
